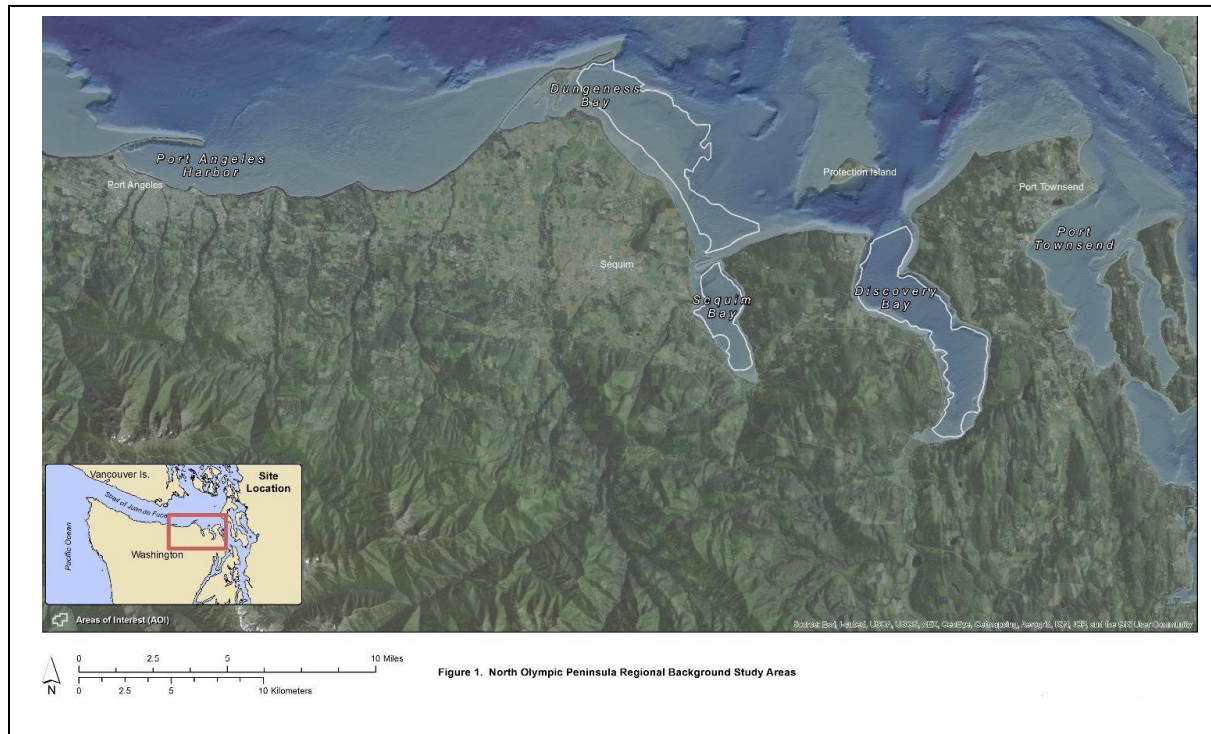
May 28th, 2013 COMMUNITY FORUM FAQ

The department of Ecology is also conducting a study of regional background sediment contamination levels for the Northern Olympic Peninsula (NOP) Area.

- The purpose of this study is to compare regional background sediment contaminant levels in this region with those in the Port Angeles Harbor, with the data to be used in setting cleanup levels.
- Please see map, below, for the NOP study area.

ESC, LLC has several concerns:

- Selection of sampling location (size, number, etc)
- Clearly defining existing contaminant sources (PCBs, etc.)
- Chemicals that will/won't be tested/analyzed
- determination of this narrowly selected area as representative of the whole region
