I understand that if this ordinance is violated, my permit is subject to revocation, and I am subject to ticketing. I also indemnify the City of Holland, its officials, employees and agents from any liability arising (including reasonable attorney fees and costs) out of my street performance. **Consent and release for story, likeness, and voice:** I give permission to the City of Holland, the City of Holland Mainstreet/Downtown Development Authority, and the City of Holland Downtown Principal Shopping District (collectively referred to as the "Organizations") to use (including but not limited to taking photographs and making audio recordings or videos), without charge and without reservation, all or a portion of my story including my likeness and my voice in promoting these Organizations. I acknowledge that editorial changes may be made as deemed suitable by the Organizations. Whether or not changes are made, I waive any rights of action I may have and release the Organizations from any and all claims I may have arising from these, publication and changes in the content, including any rights to sue for defamation or violation of rights of privacy or rights of publicity.
