1 Having considered State of Rhode Island, Office of the Rhode Island Treasurer on behalf of
2 the Employees' Retirement System of Rhode Island's ("the Retirement System") Motion for
3 Consolidation of Related Actions, Appointment as Lead Plaintiff, and Approval of Selection of Lead
4 Counsel (the "Motion") and good cause appearing therefor, the Court ORDERS as follows:

5 1. The Motion is GRANTED;

6 2. Pursuant to Rule 42(a) of the Federal Rules of Civil Procedure, *Wicks v. Alphabet,*
7 *Inc.*, No. 18-cv-06245-JSW (filed October 11, 2018); and *El Mawardy v. Alphabet, Inc.*, No. 18-cv-
8 07018 (transferred to this District on November 1, 2018) are consolidated as:

17 (a) The file in Case No. 18-cv-06245-JSW shall be the master file for every
18 action in the consolidated action. The Clerk shall administratively close the other action. When the
19 document being filed pertains to all actions, the phrase "All Actions" shall appear immediately after
20 the phrase "This Document Relates To:" When a pleading applies to some, but not all, of the actions,
21 the document shall list, immediately after the phrase "This Document Relates To:", the docket
22 number for each individual action to which the document applies, along with the last name of the
23 first-listed plaintiff in said action;

24 (b) All securities class actions relating to the same or substantially similar alleged
25 wrongdoing by defendants on behalf of the same or substantially similar putative class that is
26 subsequently filed in, or transferred to, this District shall be consolidated into this action. This Order
27 shall apply to every such action, absent an order of the Court. A party objecting to such
28 consolidation, or to any other provisions of this Order, must file an application for relief from this
Order within ten days after the action is consolidated into this action. This Order is entered without

1 prejudice to the rights of any party to apply for severance of any claim or action, with good cause
2 shown;

3 3. Pursuant to the Private Securities Litigation Reform Act of 1995, 15 U.S.C. §78u-
4 4(a)(3)(B), the Retirement System is appointed as Lead Plaintiff; and

5 4. Pursuant to 15 U.S.C. §78u-4(a)(3)(B)(v), Robbins Geller Rudman & Dowd LLP is
6 approved as Lead Counsel.

7 IT IS SO ORDERED.
