Mission and Vision Statement of the San Francisco Family Support Network

The mission of the San Francisco Family Support Network is to work collectively to achieve quality programs, coordination of resources, and policies that support all San Francisco families.

The vision of the San Francisco Family Support Network is that all San Francisco families have access to high quality Family Support services that support their optimal development.

Standards of Quality for Family Strengthening & Support

The Standards of Quality for Family Strengthening & Support were issued by the California Network of Family Strengthening Networks in 2012, and adopted by the National Network of Family Support and Strengthening Networks in 2013. They integrate and operationalize the Principles of Family Support Practice with the Strengthening Families Approach and its research-based, evidence-informed 5 Protective Factors.

The Standards are designed to be used by all stakeholders – public departments, foundations, community based organizations, and parents - across different kinds of Family Strengthening and Family Support programs as a tool for planning, providing, and assessing quality practice.

The Standards are organized into 5 sections with 17 standards, each with minimum and high quality indicators and implementation examples:

1. Family Centeredness

Working with a family-centered approach that values and recognizes families as integral to the Program.

2. Family Strengthening

Utilizing a family strengthening approach to support families to be strong, healthy, and safe, thereby promoting their optimal development.

3. Embracing Diversity

Acknowledging and respecting families’ diversity, supporting their participation in a diverse society, as well as engaging in ongoing learning and adaptation to diversity.

4. Community Building

Contributing to building a strong and healthy community by facilitating families’ social connections, developing their leadership skills, and by collaborating with other Programs.

5. Evaluation

Looking at areas of Program strength, as well as areas for further development, in order to guide continuous quality improvement and achieve positive results for families.
