

DOWNTOWN HOLLAND STREET PERFORMER PERFORMANCE REGULATIONS

(Items in **bold** have been added to due to concerns over the spread of Covid-19 and will remain in place until further notice.)

- Performers are required to have a permit in order to busk for tips. **Permits applications are accepted online only. Approved permits will be mailed to performers.**
- Permits are valid from the date of issuance through December 31 of the same calendar year.
- Permits are \$15 per individual performer and \$25 per performance group. **Group size is limited to no more than four (4) performers.**
- Permits must be displayed while performing. Groups cannot perform under an individual permit.
- Performers younger than 18 years old require special permitting. See application form.
- Performances are allowed from 10am - 8pm, seven days a week, all year long. The exception to this is during the Street Performer Series on Thursdays from June - August. You must apply in advance and be accepted into the Series to perform on Thursdays evenings.
- During special events, including the Tulip Time Festival, certain performance restrictions may apply.
- Performers are allowed to stay in one performance location no longer than two hours. Breaks should not be more than fifteen minutes. Once a performance has ended, performers are expected to leave the performance location. Performers are allowed back to a previous performance location after other performers in the queue have performed.
- **If at all possible, performers are highly encouraged to wear masks while performing and while walking to/from your performance site.**
- Performing locations in the DDA district are designated by the DDA Board. See map for approved performance locations. These are the only areas where performances are allowed. Locations are subject to change.
- Performances cannot disrupt normal business operations.
- Performers are not allowed to sell items of any kind.
- Performers may receive contributions (tips) in a receptacle such as an open instrument case, box or hat.
- Performers are responsible for cleaning up trash at performance sites.
- Performers are required to be located at least 10 feet away from business entrances and sidewalk cafes.
- Amplification and extraordinary activities performances are only allowed with proper approvals.
- **Performers must keep a six-foot sidewalk width to allow for adequate social distancing for pedestrians and not block public amenities or curb cuts.**
- No signage can be used at performance site (permits will serve as your identification).
- No loitering in performance locations.
- No smoking of any kind (including e-cigarettes) is allowed in performance locations. In addition, Ottawa County's "No Smoking Act" prohibits smoking within 25 feet of any non-food public or private establishment entrances, any operable window or ventilation system intake.
- No use of public amenities in performance locations (benches, trash cans etc.) is allowed.
- Bicycles must be locked on bike racks and are not permitted in performance locations.
- **If at anytime your performance is deemed a threat to public health or safety and you refuse to address the concerns when notified by officials, your permit will be revoked.**
- Permits are subject to revocation if regulations are being violated; in addition, performers are subject to ticketing (civil infraction) if ordinance articles are violated.
- Performers may appeal permit denials and/or revocations.

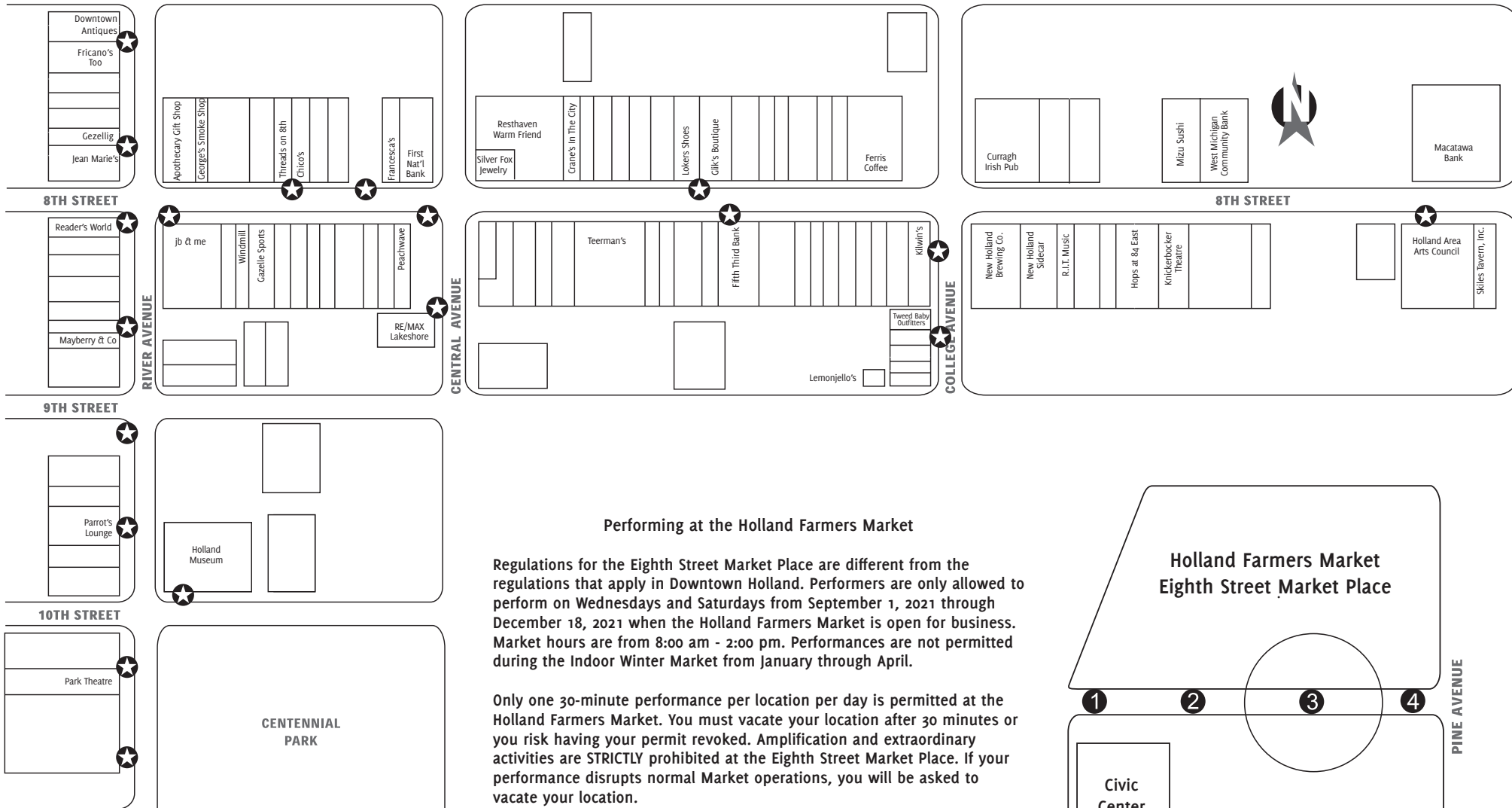

Performing at the Holland Farmers Market

Regulations for the Eighth Street Market Place are different from the regulations that apply in Downtown Holland. Performers are only allowed to perform on Wednesdays and Saturdays from September 1, 2021 through December 18, 2021 when the Holland Farmers Market is open for business. Market hours are from 8:00 am - 2:00 pm. Performances are not permitted during the Indoor Winter Market from January through April.

Only one 30-minute performance per location per day is permitted at the Holland Farmers Market. You must vacate your location after 30 minutes or you risk having your permit revoked. Amplification and extraordinary activities are **STRICTLY** prohibited at the Eighth Street Market Place. If your performance disrupts normal Market operations, you will be asked to vacate your location.
